#### Mission:

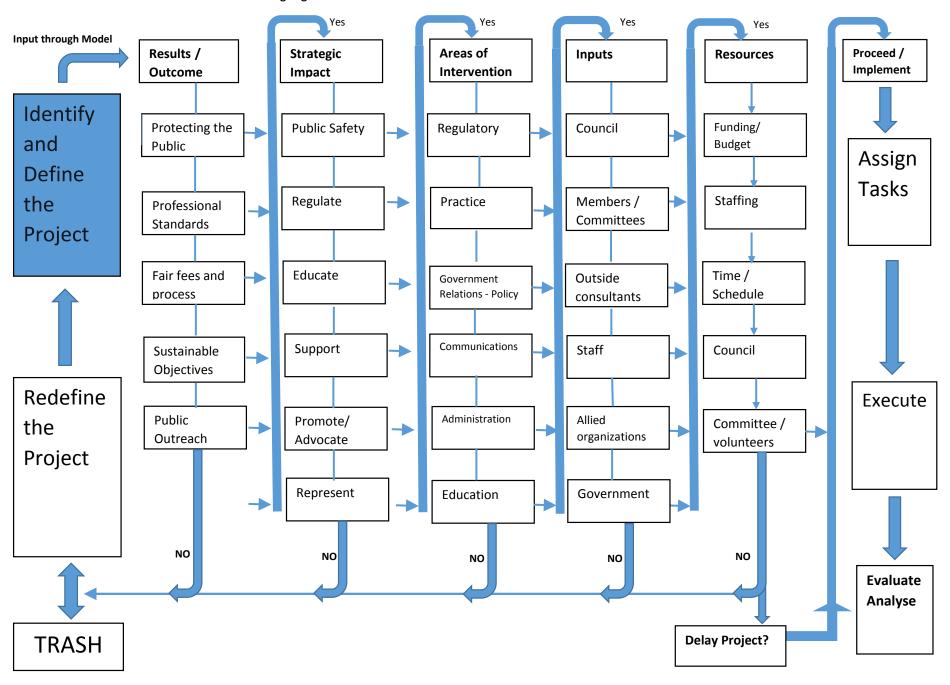
To serve the public interest through the regulation, support, and promotion of the profession of architecture in Ontario.

# OAA COUNCIL MEETINGS

### **RULES AND PROCEDURES**

Meetings of the Council of the Ontario Association of Architects (OAA) are conducted in accordance with Roberts Rules of Order which is included in the Councillor Orientation Binder, unless stipulated otherwise with the by-laws or as otherwise approved by OAA Council – see below.

# Rules and Procedures for Discussion/Debate/Motions within Council Meetings

- 1) The maximum time for a speech in debate on a motion is two minutes.
- 2) The Chair shall keep a speakers' list of those wishing to speak to a motion; and
  - a) the speakers' list shall be built in the order that the Chair notes a member's intention to speak; and
  - b) any member having not spoken to a motion shall be given preference on the speakers' list over any member who has already spoken to the motion.
- 3) An original main motion may only be introduced at a meeting if it has been added under New Business to the agenda approved for that meeting.
- 4) Meetings of the Council of the Ontario Association of Architects (OAA) are conducted in accordance with Roberts Rules of Order which is included in the Councillor Orientation material, unless stipulated otherwise with the by-laws or as otherwise approved by OAA Council.

In an effort to gain efficiencies in dispensing of Council business during each meeting, the format of the Council agendas incorporates the use of a Consent Agenda approach. The consent agenda groups materials that are regular reports or intended for information only into a single agenda item. In so doing, the grouped items can be approved or discussed in one action, rather than dispensing of each items individually. For the purposes of the OAA Council agenda the consent agenda will include the 'Executive Committee' reports and items 'For Information'.

#### Procedures for the Use of a Consent Agenda

- All documentation associated with consent items must be provided to meeting
  participants in advance. Council members must review the consent agenda
  documentation before the meeting to ensure that they are informed of the issues that
  are to be passed as part of the consent agenda.
- 2. As part of the approval process, the Chair will ask members of Council if anyone wishes to discuss any of the items listed on the consent agenda.

If it is determined that an item on the consent agenda requires discussion it will be removed from the consent portion and addressed individually.



- 5) The meeting will move to a period of informal discussion immediately after a new item has been presented and any questions on the item have been put and answered, but before an original main motion on the item is introduced; and
  - a) a period of informal discussion is defined as the opportunity to discuss an item without there being a motion on the floor; and
  - b) the Chair of the meeting when the item is introduced continues as the Chair during the period of informal discussion unless he or she chooses to relinquish the Chair; and
  - c) in a period of informal discussion the regular rules of debate are suspended; and
  - d) a period of informal discussion ceases when the Chair notes that no additional members wish to speak to the item or when an incidental motion to return to the regular rules of debate passes with a majority; and
  - e) immediately upon leaving a period of informal discussion, the presenter of the item may move an original main motion on the item and the formal rules of debate resume; and
  - f) if the presenter of the item moves no motion on the item then the item is considered dispensed unless an indication to introduce additional original main motions on the item is on the agenda, in which case each of these motions is presented in turn and debated as per the rules of formal debate.

The Senior Vice President and Treasurer presented the draft of the 2021 OAA Budget. She thanked the Budget Committee and staff for their work in creating the 2021 Budget.

Mills reported that the changes to the policy were housekeeping in nature and reviewed the proposed revisions.

A member of Council suggested that approval of the revised policy may be premature given the fact that there is a report and discussion on proposed changes to the Policy Statement as suggested by the Ontario Association for Applied Architectural Sciences (OAAAS) later in the meeting.

It was suggested by a Council member that the proposed revisions be deferred to the December meeting of Council to permit time for feedback and discussion, adding that the changes are not substantive with no urgency to be addressed.

It was moved by Gammond and seconded by Birdsell that consideration of the revisions to the Licensed Technologist OAA Policy Statement as presented by the Registrar be deferred to the December 4, 2020 meeting of Council; and, that the Registrar forward the revised draft to the OAAAS Board for comment prior to the meeting.

The President welcomed the guests to the meeting.

9053. *Reference Material Reviewed:* Memorandum from Executive Director, Kristi Doyle, Registrar, Christie Mills, and In-house Counsel, Nedra Brown dated September 23, 2020 re. Open Architecture Collaborative and attached background information. **(APPENDIX 'C')** 

Smith presented to Council a report on the activities and structure of its organization.

The President thanked the representatives for the presentation.

Farhoodi, Smith, and Tafazzoli left the meeting at 1:45 p.m.

9054. *Reference Material Reviewed:* Memorandum from Vice President Communications, Amir Azadeh and Vice President Education, Agata Mancini dated October 29, 2020 re. Shifting the 2021 OAA Conference to a Digital Platform and attached supporting documentation. (APPENDIX 'D')

The Vice President Education presented the Report outlining the three options that are being proposed to present next year's Conference in a virtual format for Council's consdieration. The Vice President noted that Option 2A is being recommended as the preferred option, noting that it incorporates both a focused conference week with a variety of events as well as activities and Continuing Education spread throughout the year.

The recommendation was supported by the Vice President Communications noting that it incorporates Council feedback in that there is value in creating a dedicated time to come together as a community, even if that is virtual.

It was noted by the Vice Presidents Communication and Education that the length of time and schedule of events still need to be finalized, adding that the recommended option allows for people to gather digitally throughout 2021 and at the same time generating excitement with Continuing Education opportunities.

A member of Council requested some clarification with respect to the variances between Options 1 and 2A.

The Vice President Education responded that with Option 1, all Conference related events would be compressed into a single week as was traditionally done for the in person format. Option 2A is a lighter version where some events would be held at different times throughout the year. It had been felt thatit would be too intensive to hold a fully digital conference in a one week time period to keep the interest of the members, recognizing that there is some online/virtual fatigue already.

It was suggested by a member of Council that there be an opportunity tentatively set aside to schedule in-person events such as a plenary or tour to allow for flexibility if the pandemic restrictions are lifted.

A Council member suggested that for an in-person event that consideration be made for the venue to be the OAA Headquarters.

It was moved by Mintz and seconded by Mancini that Option 2A – *Distributed Digital Programming* + *Conference Week* be approved with respect to planning the adaption of the 2021 Conference into a digital event(s) and that staff be directed to move forward with implementation of the proposal.

9057. Reference Material Reviewed: Memorandum from Executive Director, Kristi Doyle dated October 19, 2020 re. Broadly Experienced Foreign Architect Program (BEFA) – On-line Interview Process Pilot Program and attached background information. (APPENDIX 'G')

Doyle reported that CALA's National CACB Standing Committee is requesting approval of their proposed virtual interview pilot process for BEFA candidates as outlined in the report.

A member of Council enquired as to the reason there were seven interviews scheduled.

Doyle responded that the number is based on a number that can effectively be processed as a pilot as well as based on the funding received from the federal government to conduct the pilot.

It was moved by Murray and seconded by Laberge that Council approve the recommendation that the National Canadian Architectural Certification Board (CACB) Standing Committee be authorized to proceed with the proposed on-line Broadly Experienced Foreign Architect (BEFA) pilot process; and, be permitted to undertake up to seven BEFA interviews in a virtual setting, in accordance with the parameters identified in the Report received from the National Standing Committee dated September 30, 2020.

9058. *Reference Material Reviewed:* Memorandum from Communications Committee dated October 21, 2020 re. Ensuring Inclusive Language in OAA Communications with Respect to Licensed Technologists OAA. **(APPENDIX 'H')** 

The Vice President Communications presented the memorandum and noted that the Committee is looking at all OAA Communication initiatives through a diversity/inclusivity lens.

It was suggested by a member of Council that it may be inappropriate to consider a title or membership status with the same lens as is being used for individuals relative to enthnicity, age, gender, colour, sexual orientation, etc.

The Vice President cited an example in the area of OAA committee vacancies where Licensed Technologists OAA were not mentioned. This would not be a classification issues as opposed to a microaggression. Part of the intiative would be to push the use of the term "members" where possible.

Discussion on the topic was paused to accommodate a deputation at 2:40 p.m. Council returned to discussion on the topic at 2:50 p.m.

It was noted by a member of Council that they feel architects work hard to earn the title and it should be used as opposed to referring to all as 'members'

Mills requested some clarification regarding the initiatives in the report referencing regulatory notices and communications.

It was suggested by a member of Council that the Vice President Communications review and further refine the recommendations with a report to Council in December.

**Action:** Councillor Gammond volunteered to assist in the review of the proposed initatives with Communications and the Executive Director and Registrar.

The issue was deferred to the December meeting of Council to allow for further investigation into options.

Matelian joined the meeting at 2:35 p.m.

9059. *Reference Material Reviewed:* Deputation from member and Past President, Toon Dreessen. **(APPENDIX 'I')** 

The President welcomed Dreessen to the meeting.

Dreessen made his deputation to Council at 2:40 p.m. which had been previously circulated to Council.

The President thanked Dreessen for his deputation.

Dreessen left the meeting at 2:50 p.m.

The President suggested that Communications be directed to further review Dreessen's recommendations contained within his deputation.

#### ITEMS FOR DISCUSSION

9060. Reference Material Reviewed: Memorandum from OAA Technology Program (OAAAS) dated October 26, 2020 re. Licensed Technologist OAA – Revised Policy Statement and attached supporting documentation. (APPENDIX 'J')

The President welcomed OAAAS President, Rick Mateljan to the meeting along with the other members who joined to observe.

Councillor Gammond reported that he and Mateljan will be making the presentation on the topics of the OAAAS revised Policy Statement as well as proposed changes to the current scope of practice for a Licensed Technologist OAA (Lic.Tech.OAA).

Gammond reported on changes recommended to the current Policy Statement as outlined in the report to Council dated October 26, 2020. He noted that changes to the Terms, Conditions, and Limitations (TCL) should be considered, suggesting that the rights to the licensee are very limited and not commensurate with the status.

It was suggested by Gammond that the Act and Regulations apply to both Lic.Tech.OAAs and Architects equallyhowever, the rights and privileges given to each are imbalanced. Revisions are being proposed with respect to voting rights and the structure for ownership of architectural practices.

Gammond noted that a Lic.Tech.OAA on Council is be permitted to run for Executive Committee including President, however not permitted to vote in the election of architects to Council.

Gammond reported that the proposal suggests reasons why it is felt that the scope of practice is not appropriate, and represents a correction of the current scope to what it should have been at the time it was established. Three primary concepts include:

- 1. Flexibility and occupancy types:
- 2. Size (revise from 600 to 1800 sq.m.)

#### 3. Application of size restrictions

Gammond suggested that differences may be noted in academic training, however, the experience required is similar the Internship program.

Matelian reviewed in detail the specific proposed changes to the current scope of practice.

A member of Council enquired as to what changes in training have occured to justify the increased scope of practice and whether the public is protected by increasing the scope.

Gammond responded that the academic standards have changed with a new standard for college programs issued by the Ministry.

Gammond clarified that changes in size within the proposed scope are for only mixed use buildings.

A member of Council enquired as to whether OAAAS has considered addressing its concerns with the government relative to the scope of those with a BCIN number as well as including legal consultation.

Mateljan responded in the negative adding that it is expected that government would not entertain such consideration.

It was suggested by Doyle that the proposals are detailed and complex and therefore a mechanism or task group is needed to allow for the OAA to further review and consider the proposals.

It was suggested by a Council member that the proposed change in size would place the work by Lic.Tech.OAAs into Part 3.

Mateljan responded that gross area and building area are different and is therefore not in the category of Part 3.

The President thanked Mateljan for his presentation, noting that the information will be taken away for further discussion and feedback. The intent would be to bring this back to the December meeting of Council for further consideration.

Mateljan left the meeting at 3:50 p.m.

9061. Reference Material Reviewed: Memorandum from OAA Technology Program (OAAAS) dated October 26, 2020 re. Licensed Technologist OAA – Scope of Practice and attached supporting documentation. (APPENDIX 'K')

The report was discussed under minute number 9060.

The President returned to items for review and approval in the agenda.

9062. *Reference Material Reviewed:* Memorandum from Communications Committee dated October 20, 2020 re. Assessing Membership Engagement in the OAA.chat Public Forum and attached supporting documentation. **(APPENDIX 'L')** 

The Vice President Communications reported that use of the OAA.chat member engagement site has been low. Approximately 2.1% of members are on OAA.chat and the numbers of those conversing and/or posting is low.

It was suggested by the Vice President Communications that there is hesitancy by the membership to comment on OAA social media sites, adding that if there is a desire to grow the OAA.chat then there may be a need to address pre-conceived concerns of reprisals or criticism from the OAA as the regulator.

The Vice President Communications suggested that 'cultivation of trust' be added for discussion at next year's Priority Planning Session.

A Council member suggested that there may be too many channels and areas of communication including social media which results in members not wishing to be involved in yet another online communication tool.

The Vice President Communications responded that social media and all communication is now multichannel, adding that it is important to reach out to the diversity of OAA members.

Laberge left the meeting at 4:35 p.m.

It was suggested by a member of Council that historically there is a potential for decline of social media sites over time. The OAA.chat was created not to be anonymous so as not to allow for trolling.

A Councillor suggested that the slow start may be attributable in part to it being new as well as the effects of the current pandemic.

It was noted by a member of Council that the President's society visits are important in the communication with the members, adding that they would like to continue to see it enhance through technology. The report was received for information and the Vice President, Communications noted that a second report on the use of OAA.chat will be presented to the December Council meeting.

The Vice President Education reported that the Committee is recommending that two specific topics of mandatory education be be introduced for the next Education cycle, clarifying that the number of hours is not being increased. The two topics mandatory topics identified are a course on the *Architects Act*, and the other on Equity, Diversity, and Inclusivity (EDI).

A member of Council enquired as to the cost implications for members as well as their availability.

The Vice President Education responded that the course on the Act would be approximately \$150, and the EDI courses offered through CCDI vary in price. The number of offerings have yet to be confirmed.

A member of Council enquired as to whether the topic only deals with the Act or is professional responsibility included.

A Council member suggested that they were opposed to the mandatory requirement as there are other areas where members need improvement as well as there being a cost associated with the courses.

The Vice President Education suggested that OAA could offer once again a course via CCDI at no charge to members. A member of Council stressed that in order to make an informed decision they would need to better understand the cost implications.

There was some suggestion among Council to make the annual license renewal in part contingent on completion of the EDI course.

A number of Council members noted that they support the idea of educating members on equity, diversity and inclusivity, however not that it be made mandatory.

It was noted as well as the technical details of implementation and transcripts are not yet defined.

Doyle noted that if Council wishes to add further mandatory requirements for licence, a change in the legislation would be required. The OAA cannot add additional licence requirements without legislative authority.

**Action:** the Vice President Education was directed by Council to further review the proposal for mandatory Continuing Education and report back to Council in December including cost implications, program content, and availability of courses on the topic.

Erskine left the meeting at 6:00 p.m.

Subject: Mandatory Continuing Education requirement for minimum

learning hours of accredited programing focused on Equity,

Diversity, and Inclusion.

Objective: To seek Council approval to introduce in Continuing Education Cycle

2021-2022 a mandatory requirement for a minimum of one learning hour of accredited programming focused on Equity, Diversity, and

Inclusion.

The OAA's Continuing Education Program is in place to ensure OAA members are able to respond to professional obligations to clients, the public and the profession. This program ensures that members remain current with the technologies, business practices and methods of their profession. The *Architects Act* requires members of the OAA to participate in and comply with the Continuing Education Program.



#### Continuing Education Program - NEW Mandatory requirement

The Comprehensive Education Committee recommends introducing a mandatory requirement for minimum learning hours of accredited programing focused on Equity, Diversity, and Inclusion.

The recommendation is based, in part, on the results of the recent survey. The OAA's Membership Survey administered in fall 2019 received 1,461 responses which represents a response rate of 25%. Of those respondents 30% have experienced discrimination and/or harassment in the workplace, 60% indicated that they have not and 10% preferred not to answer. 62% of instances occurred within the last five years from when the previous membership survey was conducted; 32% occurred less than a year prior.

Of all the female respondents 52% of them indicated that they experienced harassment or discrimination, 32% did not and 12% preferred not to answer.

The top sources of discrimination were sex (22%), age (17%), family or marital status (14%), ethnicity (12%) and race (8%) but also included religion, sexual orientation, gender expression, gender identity and language/accent/articulation. 18% of women and 5% of men who have experienced harassment and/or discrimination preferred not to provide the source.

Professional misconduct as indicated in R.R.O. 1990, Reg. 27, s. 42 (54) includes "Conduct or an act relevant to the practice of architecture that, having regard to all of the circumstances, would reasonably be regarded by members of the Association as disgraceful, dishonourable or unprofessional."

As a regulator, the OAA has a duty to investigate conduct that may contravene the Act. Harassment and /or discrimination within the workplace may be considered a contravention to the section stated above when referred to and determined by the Discipline Committee of the OAA. Only issues which are reported can be investigated and dealt with. Unfortunately, the majority of instances of harassment and discrimination go unreported due to the potential backlash and negative effects on the life and livelihood of the victim. Among a plethora of statistics and surveys on this matter taken nationally and worldwide, this is also illustrated in the member survey, which, despite being anonymous, had a significant number of members preferring not to answer the question regarding occurrence and source. Lack of reporting should not mean that the OAA does not have responsibility to address matters in regard to this very obvious and problematic behaviour in its membership.

The CEC believes that a course on Equity, Diversity and Inclusivity, mandatory for all members, is an appropriate step to take towards addressing this issue. It is not expected that attending one EDI course will solve the problem, rather the approach is meant to promote discussions on the issue and to educate members on both appropriate behaviour as well as potential courses of action when faced with discrimination and/or harassment in the workplace.

#### Canadian Center for Diversity and Inclusion Webinars.

The proposed minimum requirement on the matter of Equity, Diversity, and Inclusion (EDI) can be fulfilled by OAA membership by taking webinars currently offered by the Canadian Center for Diversity and Inclusion (CCDI).



Financially speaking, there are two scenarios possible, depending on the speaker rate that is used to calculate the expenses.

#### Scenario I

CCDI webinars are offered at a current flat speaker rate of \$1500 per webinar.

Considering the next continuing education cycle is 18 months and assuming that the EDI webinars are offered on a monthly basis, the related speaker expenses will account for \$27K. The costs will be distributed over two fiscal years: \$18K in 2021 and \$9K in 2022 fiscal year.

The EDI webinars are recommended to be offered to OAA members at no cost i.e. there will be no enrollment-generated revenue to offset the related costs.

#### Scenario II

CCDI webinars are offered at a reduced speaker rate of \$1000 per webinar.

Considering the size of the OAA membership and the compulsory nature of the requirement, it is not unreasonable to try to negotiate a special speaker rate for the webinars offered to OAA members. If we succeed in reducing the current flat rate to \$1000 per webinar, the very same 18 webinars will cost \$18K. As in the first scenario, the expense will be distributed between 2021 and 2022 fiscal years as \$12K and \$6K respectively.

Despite previous membership pushback regarding mandatory courses, the Committee feels that the currently proposed administration of mandatory courses differs from its predecessor in several ways. Firstly, the required education accounts for only one hour and will be a part of the existing requirement of 25 structured learning hours. Secondly, the matter of Equity, Diversity, and Inclusion is not limited to a specific project typology, firm size, or other aspect that may not apply to all architects. Rather, the topics of Equity, Diversity and Inclusion, is of fundamental importance for all architects licensed to provide services to the public.

#### Action:

To seek Council approval to introduce in Continuing Education Cycle 2021-2022 the mandatory requirement for a minimum of one learning hour of accredited programming focused on Equity, Diversity, and Inclusion, and direct staff to determine the best way in which to implement the requirement given the very short time frame in which to prepare for the start of the next cycle i.e. January 1, 2021.

Subject: Assessing OAA.Chat as a Digital Collaboration Tool for All

**Committees and Staff** 

Objective: To share the Committee's review of current Committee use of the

private forums on the OAA.chat resource.

The OAA Communications Committee had been tasked to assess the current status of OAA.chat, along with its strengths, weaknesses, and opportunities for growth. OAA.chat has two main parts: a *public forum for members* and a *private committee workspace*.

At the previous Council meeting, the Committee reported low use of the site's *public forum*. If the *public forum* alone is to continue as a public membership engagement tool, Council was encouraged to consider ways to "cultivate trust" at its 2021 Priority Planning Session. At that time, it is recommended that the viability of solely the *public forum* portion of OAA.chat be reassessed as part of Council's ongoing membership engagement strategies.

Until now, staff have been asked to cross-post content to the *public forums* of OAA.chat with the aim to increase the number of members on this platform. While this has technically proven to be a successful strategy for solely increasing the number of members, this success has had no impact on the lack of organic involvement by members. Collected data analysis shows that once members sign



up to the public forum, they do not participate or initiate any conversation—this may be due to the aforementioned trust analysis by Communications Committee.

For this report, the Communications Committee has now turned its attention to the use of OAA.chat as a *digital collaboration tool for OAA Committees*. The site offers forums accessible only to OAA Committee or Council members. Such private digital spaces are intended to facilitate discussion in between the scheduled meetings. Committee members and OAA staff can post minutes, agenda items, and other documents, as well as have discussions, share files, vote on selections, etc.

Previously, the Communications Committee used solely email to interact between meetings. On specific occasions necessitating collaboration on files, Google Drive would be used to allow for access to spreadsheet workbooks. Similar adhoc approaches have been taken with other OAA Committees, but there was no uniformity to processes. Having consistency across the board would be welcomed, as it streamlines workloads for staff and sets expectations for volunteers who may be part of several Committees.


#### Pilot program

Upon OAA.chat's soft launch in the spring, three pilot Committees begin using it to explore its functionality for collaboration between meetings:

- Sustainable Built Environments Committee (SBEC);
- Policy Advocacy Coordination Team (PACT); and
- Communications Committee.

In early November, a survey was sent to support staff and individual members of these Committees, seeking opinions on experiences thus far and whether OAA.chat met their needs. The majority of respondents checked the forums "occasionally" (42 per cent) or "only when instructed" (31.6 per cent).


# How often do you check OAA.chat?





However, when asked, "Do you prefer to use a tool like OAA.chat or email as means of communicating in between meetings or sharing files, etc?," almost 80 per cent preferred to use solely email, rather than the online message board.

Given this reaction, the Communications Committee cannot recommend extending the pilot project to other Committees using OAA.chat for official work.

While many respondents like the simple design of OAA.chat, the overall concern seemed to be whether a forum was truly necessary for Committee work. Comments included frustration over needing to check yet another site (and remember another password) to a duplication of efforts for OAA staff who needed to share resources both via OAA.chat and email.

Additionally, the Committee feels moving to online forums can bring the feeling of an unwelcome 24/7 pressure to a volunteer position, subtly forcing Committee members to check the chat repeatedly and increase their volunteer workload. There is also concern the chat environment inherently sets up an expectation for immediate responses lest being shut out of a decision. Further, while having Committee conversations "archived" is beneficial for institutional memory, there was concern having a permanent, less-private library of comments may hinder some frank discussions.



#### **Next Steps**

While the results of the survey, and the Committee's own discussions, suggest a message board is not needed for collaborative work, there is merit in having a one-stop-shop for all Committee files. However, it was pointed out that this already exists in the form of iMIS Communities.

OAA Committees can easily have access to their own iMIS Communities pages through logging in to secure.oaa.on.ca. This simple site allows the posting of attachments in an easily organized filing system. Already used by Council for packages and agendas, increasing Committees' access to the Communities pages would offer a consistent experience for Councillors who also sit on multiple Committees, keeping all files in one location.

It is the Committee's understanding that the OAA is exploring an iMIS upgrade, and also pursuing an operational review in the coming year. By liaising with the various Committees to ensure their needs for collaboration are understood, it could well be that an existing solution—iMIS—will offer the easiest, most uniform approach.

As a result of the survey findings of the three pilot Committees, the Communications Committee will no longer continue its pilot test of OAA.chat for collaborative work. Staff will no longer be requested to cross-post to the public forum. As a next step, it is recommended the Communications Committee proceed to understand the needs of all OAA Committees before making a final decision on a system-wide digital collaboration tool.

#### Action:

Council is to direct Communications Committee to explore more options for a system-wide digital collaboration tool between OAA Committees that take into account the needs of both volunteer members and staff.

It is recommended that Council reassess the viability of the public forum portion only of OAA.chat at its 2021 Council Priority Planning session as part of ongoing membership engagement

strategies.

Subject: 'Building Back Better' Panel Discussion

Objective: Council to consider approval of the proposed panel discussion --

'Building Back Better'.

Council is asked to consider approval of a proposal for a virtual panel discussion that would highlight work that has been done by architects to achieve net zero buildings. The working title for the event is "Building Back Better".

Objective: While the profession is aware of the significant economic and climate mitigation advantages of zero carbon buildings into the future, the public, including government officials and financiers are not. The target audience would be primarily those in the financial/government sector, however the public and OAA members would be invited to attend. This initiative is in direct support of Council's objectives around climate stability and also financial literacy. The more informed decision makers are, the better the profession will be positioned to offer solutions to address climate stability.

Panel: The panel would be moderated by a professional host or media professional, possibly from CBC. It would include a short presentation by 2-3 Ontario architects/practices which have designed net-zero buildings -- There are in fact seven OAA-award winning examples. Additional panelists would include an individual from one of the well known business schools. It will be important to connect capital expense with operating expense.

*Timing:* It is suggested that the panel could be hosted next spring, and perhaps a feature element of the OAA's virtual conference week 2021.



Cost: Since the event would be virtual, the costs are likely to be minimal. Honoraria or speaker fees are noted as a cost as well as the technical programming that may be needed to produce the panel discussion. It is estimated that the event could be hosted for approximately \$6,000.

With Council's approval to proceed, I will work with OAA Executive Director Kristi Doyle to reach out to a few suggested panelists to gauge their interest and availability. An update on the agenda and format will be provided to Council in January. It is noted that staff resources will be required, specifically in the area of communications.

The attached letter to MMAH Minister Stephen Clark is presented for Council's review and approval. This letter has been drafted further to additional conversations regarding the lack of building related infection control measures within the Building Code. These conversations occurred during a recent meeting with one of the local societies as well as Executive Committee.

Council will recall that the crisis that has occurred this year in relation to the COVID-19 pandemic within our province's long-term care facilities has been a matter discussed by Council a number of times this year. The following motion was passed.

It was moved by Vilardi and seconded by Speigel that the Vice President Communications and Vice President Education to work together with OAA Communications staff to review and post content amplifying the intersection of architecture and congregate living for vulnerable populations.

It had also been noted that staff would monitor the results of the Commission that has been established to study this issue and that further action would be considered accordingly.

Executive Committee has reviewed the attached draft letter and has agreed in principle that the letter should be sent before the final report and recommendations of the Commission are issued.

Dear Minister Clark.

I am writing on behalf of the Council of the Ontario Association of Architects (OAA) in support of our self-regulating mandate to protect the public interest.

As you are aware the OAA is the regulator of the province's architecture profession. The *Architects Act* and its Regulations, along with other regulatory tools such as the Building and Fire Codes, help protect the health and safety of Ontarians within the built environment.

The deaths that have occurred this year in relation to the COVID-19 pandemic within our province's long-term care facilities is nothing less than a tragedy. We support the government's initiatives to address this matter and urge that it be done swiftly. Our Council and other members of the architecture profession have been involved in much discussion regarding the design of long-term care facilities as well as other congregate living spaces since the pandemic began. We agree that change is required.

On June 1, we wrote to the Minster of Long-Term Care, Merrilee Fullerton, with an offer to contribute to the work of the independent commission. We continue to stand ready to assist, now and into the future as recommendations are developed based on the work of the commission.

We acknowledge that there are many factors that have contributed to this crisis and that the work of the commission is focussed on a broad range of issues. At this point, however, we feel it is of paramount importance to bring to your attention, as the Minister responsible for the Ontario Building Code, the lack of building related infection control measures.

its gap regarding infection control. It is our position that this matter should be addressed immediately through code changes that would clearly articulate required safety measures to control the spread of infection. At the very least, infection control should be specifically identified as a life safety issue in all congregate built spaces.

The OAA would be pleased to work directly with Ministry officials to formulate appropriate code changes and in doing so assemble a group of architects who have considerable experience and expertise in health care facility programming and design. We look forward to your early response.

As a reminder, the following resolution was passed by a vast majority vote of the membership at the Annual General Meeting of the members held on August 6, 2020:

Be it resolved that the OAA Council immediately rescind the requirement for mandatory electronic stamps and at the 2021 Annual General Meeting, present a report to membership on the efficacy of the entire stamp system and its ability to meet the OAA's core mandate of ensuring that all proposals submitted to municipalities governing the construction of building within the scope of the Architects Act

Council considered this member resolution at the September Council meeting and after discussion passed the following Council motion:

It was moved by Birdsell and seconded by Vilardi that the mandatory requirement for OAA members to obtain a digital seal offered through Notarius be rescinded effective immediately; and, that this direction be communicated to the members in the coming week; and, that the Executive Director and Registrar be directed to identify the existing options regarding seals to members in that communication; and that, a report be presented to Council at the November meeting to consider the second portion of the members' motion.-- CARRIED (10 in favour, 2 opposed, 3 abstentions)



In accordance with that motion, notice was provided to the membership via Special OAA News on September 29. A copy is attached. The notice advised of Council's decision to immediately rescind the mandatory requirement for digital seals and outlined the options regarding seals for members.

The purpose of this report is to bring forward to Council the second portion of the members' resolution:

"....present a report to membership on the efficacy of the entire stamp system and its ability to meet the OAA's core mandate of ensuring that all proposals submitted to municipalities governing the construction of building within the scope of the Architects Act."

As an additional reminder, the OAA By-laws require Council to consider a member resolution within three months from when it is passed, however it is noted that the motion is not binding on the Council. As such, Council may wish to consider various approaches to address this question, as is, or in an amended format.

The following are a few points of information that Council may wish to consider in deciding next steps based on my discussions with the Registrar as we implemented Council's direction from the September meeting in regards to rescinding the mandatory requirement for e-seals.

The professional stamp/seal system is one that is used by a number of professions in order to signify a professional is taking responsibility for the 'work'. Council may wish to first gain a better understanding of the issue being raised in the members' resolution, and whether there is evidence to support further study i.e. is there a problem? Does the concern really lie with the efficacy of the seal or is the issue centred around the control of document and public dissemination and/or education of building officials?

Historically, the most prevalent regulatory issue related to stolen seals occurred when a client used an architect's sealed drawings after the client-architect agreement had terminated without the architect's permission or knowledge. In 2016, the OAA enforced, through injunction, an instance of a fabricated seal. So to the point above, "what is the problem we are trying to solve". Meaning that, if there are issues with fraud or misuse of a member's seal will they be solved by security? Or would the issues persist no matter what level of best practice seal/document security the OAA recommends to its members.

It would seem that many practices develop methods of how they seal and secure documents that work for their scale and type of work. It has been suggested that documents and seal images are most vulnerable when they are out of the control of the architect or Licensed Technologist OAA. One example is when a project is restarted after having been put on hold for a number of years and the client uses the original architect's documents without permission. The second example is when municipalities make project application documents available for view to the public on their websites. This is an issue that we have discussed before with groups like the City of Toronto.

This leads to the notion that more communication and education is needed at the building official/planning department level in respect to how they treat sealed documents. In addition, more education around enforcement of professional



design requirements as set out in the *Architects Act* by municipal official may be of particular importance in this discussion.

Again, the above information is simply provided as some initial thoughts based on conversation that myself and the Registrar have had over the last few weeks. A more fulsome discussion among Council is required in directing next steps on this matter

#### Motion to Rescind the Requirement to Make Notarius Seals Mandatory.

The core mandate of the OAA is to protect the public by ensuring that buildings within specific categories are designed competently. The OAA executes its mandate through a licensing process requiring education, experience and exams, continuing education, and through ensuring that municipalities only accept designs sealed by licensed architects. Until January 2022 architects can signify that they are licensed by applying the digital image of their rubber stamp, to SPA/Permit drawings. Municipal employees can then check that the name on the stamp has a current license by referring to the OAA website.

In November, 2018, the OAA moved to a mandatory electronic system provided by an outside provider, Notarius. As of January 2019, new requests for seals have been issued solely in this digital format. Effective January 2022, all architects must exclusively use the Notarius electronic seals to seal documents.

There are several problems with this decision:

- It only addresses the legitimacy of the stamps, which is a small part of ensuring that all buildings within the scope of the Act are designed by architects.
- Architect's seals are used primarily on documents submitted to authorities having jurisdiction, and on documents related to contract administration. Authorities having jurisdiction accept digital representations of the stamp.
- Commonly available, inexpensive and effective software can be used to lock drawings and documents.
- This system does nothing to address the issue of whether municipalities are recognizing when the stamps are required, which is anecdotally a larger problem.

This system is not paid for from existing fees. At \$140 sign-up fee and \$185/yr, this amount is affordable for many architects. However, it represents a 20% increase in license fees, and approximately \$750,000 per year for Notarius, of which the OAA gets 5%. This is significant cost for a system that is solving a non-existent problem.

#### I support the following motion:

We move that the OAA Council immediately rescind the requirement for mandatory electronic stamps, and at the 2021 Annual General Meeting, present a report to membership on the efficacy of the entire stamp system and its ability to meet the OAA's core mandate of ensuring that all proposals submitted to municipalities governing the construction of building within the scope of the Architects Act.

#### OAA Council Considers Members' AGM Resolution Last Week

#### Discussion Results in Decision to Rescind Mandatory Requirement for OAA Digital Seals Through Notarius

The OAA has removed its requirement for a digital seal issued through Notarius. The decision was made at the OAA Council meeting on Thursday, September 24, and is effective immediately.

A members' resolution to rescind the mandatory requirement for new OAA seals to be digital via Notarius was approved at the Annual General Meeting in August. As per OAA By-laws, Council explored this matter, having a lengthy discussion that capped off months of reviewing and evaluating OAA seal use.

Previously, Notarius digital seals had been mandatory for new applications, as of January 2019, for Architects and Licensed Technologists OAA. This would have been extended to all Members as of January 2, 2022. However, with the requirement rescinded, both physical and digital OAA seals, accompanied by high-resolution seal images, may now be applied for and used. Members may make their own choice.

More information will be shared with the membership as Council continues to explore this transition and also considers the additional aspects of the members' resolution, which include a review of the digital seal program in general as well as consistent requirements for professional seals by municipal officials. Further discussion is planned for the next Council meeting, which is scheduled for November 5.

#### IMPORTANT INFORMATION FOR THOSE WHO REQUIRE A SEAL

If you require an OAA seal from this point forward, you will have two choices—digital or physical. Follow the instructions on the OAA Website related to the Notarius digital seal, or apply for a physical seal directly from the OAA through the Office of the Registrar. In both cases, you will also receive a complimentary high-resolution image of the member seal.

# IMPORTANT INFORMATION FOR THOSE WHO ALREADY HAVE A NOTARIUS DIGITAL SEAL

Those already using Notarius digital seals and high-resolution seal images can continue using them. However, if you wish to obtain a physical seal, you can proceed with an application by contacting the Office of the Registrar, and a seal will be provided to you at no cost. (Please note: this only applies to those who signed up for a digital seal before September 30.) Refer to Regulatory Notice 1 for information related to seal application and usage best practices.

**Objective**: To report on existing resources and activities in support of

professional fees in response to the action directed by Council in

March 2020 as noted below.

The 'Action' as directed by Council at the March 2020 meeting following a discussion about professional fees is noted below. Council's direction was focussed on specific program areas and has been parsed accordingly below. The update and/or responses are noted below each (no italics).

#### March 5, 2020 Council - excerpt Open meeting minutes

**Council Action Item:** Moving forward it was agreed that the following elements would be considered in the strategy around professional fees under current initiatives:

 Qualification Based Selection (QBS) – under the Vice President Strategic/PACT portfolio: Updating of the OAA QBS documents, consider participation in the national study being proposed which will provide stronger evidence as to why lowest price is not best. Based on these two items develop better information and marketing tools for QBS that can be rolled out to procurement folks, and to members.

#### **QBS**

The OAA formally presented its new page on Qualifications-Based Selection (QBS) earlier this fall. The OAA has been a long-standing advocate for QBS, and has worked in partnership with other industry associations and through the



Construction Design Alliance of Ontario to try to secure a broader adoption of QBS in the industry. As part of these early efforts, the OAA had developed a "QBS Kit" with templates for procurement officials. In 2019, direction was given, based on the recommendation of the Practice Resource Committee, to review and update those documents along with the communications plan. OAA Council approved hiring a consultant to coordinate a review and rewrite with more of a focus on marketing of QBS.

The new web page provides an overview of what QBS is (and isn't), advocates for QBS as the best practice for procuring professional services, and provides links to various QBS resources. The former "QBS Kit" has been archived, but can still be accessed via this page.

Feedback to date on this refreshed resource has been positive.

#### North American Study on QBS

The OAA has supported a study titled 'The State of QBS' which is being overseen by ACEC USA and QBS Canada. It is an update to a 2009 study of American QBS usage and benefits. This new study now includes Canadian QBS data – with the Canadian data included as part of the overall study and also separated for the Canadian market as well.

The results of this study will be critical in OAA's work to advocate for the use of QBS such that it will objectively quantify the QBS benefits to the owners of projects and demonstrate how better procurement that is not price focused can deliver better value for the owner and the community it serves. The group is on target for a completion of the study in the first half of 2021. Once that is released, the OAA can work on further education and communication of both client groups, the public and members.

 Architects Act and Regulations – under the Vice President Regulatory/Regulatory portfolio: how the legislation might be further strengthened to support and enforce the matter of charging 'fair and reasonable fees'

#### Fair & Reasonable Fees and Regulatory Considerations

A working group continues with the research that is underway to consider strengthening the regulatory and legal framework of the profession around unreasonable contract language. The issue of fair and reasonable fees is also under discussion.

The following is a summary of the regulatory considerations as discussed with the Registrar and Vice President, Regulatory.

Architect's professional fees (remuneration) does not explicitly exist as a legislated item in the *Architects Act* or Regulations. Remuneration is only mentioned in the *Architects Act* and Regulations insofar as the Association's ability to gather historical data which would be considered very different from prescribing or advising on professional fees.



A memorandum of law on file on the topic of professional fees and the *Architects Act* concluded that "it would not be appropriate for the architects (the Association) to promulgate a minimum fee schedule". The conclusion was based on case law as related to the *Competition Act* (R.S.C., 1985, c. C-34) (sometimes referred to as the *Combines Act*).

It is a fairly common legal position that trying to fix, establish, enforce, administer, or direct the fees for professional services via the legislation for a self-regulated profession is contrary to the very purpose of the Act. The provincial legislature confers on the professional association of architects (the OAA) the right to govern themselves and the professional conduct of their members. The power of self-government includes the power to admit persons into the profession and the power to regulate the conduct of the members of the profession.

From a regulatory perspective, it is the conduct and competence of the Ontario architect that is our main concern. The public should expect a professional level of service regardless of the agreed to fee. This highlights the importance of responsibility of our members to understand how to price their work.

The more tools and training the OAA can provide members related to understanding their practice value the more adept they will be at pricing their work in consideration of the various risk levels of projects and how that risk fits into their business plan.

 Education: - under the Vice President Education and Vice President Practice portfolios: Review all information that is already available to members regarding professional fees, specifically how to price services, and ethical considerations – and how to develop more awareness/education. Information already exists in: Practice Tips; CHOP; MBA Kit and Excel sheets; RAIC guideline to fees and services; Fundamentals of Starting an Architectural Practice; Admission course. Also consider this in the context of the research under way to consider whether/how to strengthen our two-tier licensing i.e. requirements for a Certificate of Practice.

#### **Practice Tools**

Practice Advisory Services (PAS) is reviewing information available to members to see how more awareness and understanding can be raised regarding the tools and resources currently available through the Website. This includes Practice Tips; the Canadian Handbook of Practice; The MBA Kit; Work Breakdown Structure Excel sheets; and the RAIC guideline to fees and services. All of these resources address professional fees. In addition, discussions are underway to create short information pieces by video, as well as full webinars to discuss these various resources and their intent and use.

In addition, PAS and Communications staff have continued to incorporate content on professional fees in the quarterly Practice Advisory e-newsletter.



PAS is also working with Communications in developing a series of tweets, LinkedIn posts, and Facebook posts that would cover information already available to members regarding professional fees.

#### **Education Opportunities**

The OAA's Fundamentals of Running an Architectural Practice contains a module focused on Bidding and Fees.

The 2021 Roster of bi-weekly webinars includes two sessions focused on Financial Literacy.

The following segments of the OAA Admission course touch on risk management and assessment of professional fees - Legal Aspects: Professional Liability and Contracts.

The OAA also actively communicates outside educational opportunities to members such as the upcoming 2-day seminar titled 'Legal Guide to Managing Contracts & Risk in Design Projects' which starts December 4, 2020.

#### **Two-Tier Licensure**

The working group is continuing its research to consider strengthening two-tier licensure i.e. requirements for a Certificate of Practice and consideration of practitioners being 'business ready' which includes determining appropriate professional fees and services.

Communication – under the Vice President
 Communications/communication portfolio – consider a blOAAg
 series on determining appropriate fees. Also better understanding of the onus on the profession to charge the appropriate fee.

Communications has been working with above service areas in terms of enhanced communication plans and opportunities for advancing information and education around professional fees and will continue to do so.

A call for short stories to be posted on the blOAAg on determining appropriate fees, and/or understanding of the onus on the profession to charge the appropriate fees had been put to out to VP's and others, however, nothing has materialized as of yet. I had reached out to the VPs about having them author pieces or recommend authors, but no one seemed to bite at the response.

#### New Ideas for further discussion and consideration

Further to the review and assessment of tools, resources, education and other activities that the OAA has to support members, the public, and client groups in understanding professional fees, a number of new ideas surfaced as noted below and will be explored further.

#### Creation of a Fee App

It has been suggested that it would be useful to have a tool for client use on the OAA website, with building type and dollar range of fees from high to low (including related fees such as construction values and other associated fees (not just project fees).



#### **Centralized Webpage for resources**

Creation of a centralized fee resource page on the website highlighting existing resource to members

#### Collection of data on a voluntary basis

Collection of historical data on fees researched from public sources to be public information (useful to estimate current market rates). The membership could also voluntarily submit fees to create a repository of information. School Boards publish fees submitted by practices which could be uploaded to the OAA website. It must be noted, however, that a low fee posted would become the average (assuming there will be competition around it) if architects are competing on a low fee basis. It would be preferable if the average fee was posted, otherwise it becomes a race to the bottom. On the website, add high level information for the public about what forms the basis of a project fee and what hourly rates represent, etc. This goes back to the discussion of "value of time".

#### **Engaging Local Societies**

The OAA's local Architectural Societies could advocate for QBS and reach out to client groups locally. A concerted effort is required across the province. A toolbox and strategy is required. A script could be prepared for Societies to use in their effort, and to tag team all members of a Planning Committee. Make it easy by providing them with a motion to present to their Council. MPPs want to engage with local issues, so this is where connections could start and grow. The City of Edmonton had good results with QBS and the Toronto Community Housing Centre (TCHC) modelled itself on the City of Edmonton in not selecting on fees (within 0.5% on public tariff). PAS is putting emphasis on the fact that it is better to base criteria on quality and qualification than on fees.

#### **Enhancing the OAA Admission Course content**

Enhancement of the content of the Admission Course section which is dedicated to practice management. This would provide further education to individuals at the interns stage in terms of value of time and determining appropriate fees.

these discussions and efforts.

**Subject: Report from Executive Director** 

**Objective**: To provide Council with an update on activities of the Executive

Director not covered elsewhere in the Council agenda.

This report outlines specific activities that have occurred which have not been reported elsewhere in the Council package since the November meeting.

#### Internal and Administration

New Communications Specialist, Cynthia Mykytyshyn is now on board and working through orientation and on-boarding with the Communications staff team.

With the second lock down now in place in Toronto, and other regions, the OAA Headquarters continues to be closed to the public and members. Over the fall months there had been a few occasions where small meetings were held at the OAA, however any further in-person meetings have been cancelled and will be held virtually. Individual staff are still occupying the building on a periodic basis. Safety protocols and procedures are in place in accordance with government and health officials' directives and guidelines for anyone who does attend the building. OAA Maintenance Technician, John Thomas continues to be onsite, full time, each day to ensure security of the building as well as receive mail and deliveries.

I continue to conduct a general staff meeting once a week as well as my individual meetings with the various service areas. The most recent staff chat included a short presentation by the Manager of Communications on the use of our new template documents. On November 4, we had a short presentation from the Manager of Education regarding the 'end of cycle' process.

On November 23, we held our monthly team leads meeting.

Council may recall recent information regarding implementation of the new *Not-For-Profit Corporations Act* and sections that the OAA would like to have included within our Regulation to guide the administrative affairs of the OAA. I have received notice that the government has extended the deadline for enactment of regulations under the NFCA and therefore we continue to wait for feedback from the Ministry of the Attorney General on final regulatory changes that would apply to the OAA.

I have reached out to the new Director of Practice at RAIC, Paul Mitchell as a courtesy to congratulate him on his new role. Mitchell is a past president of the OAA.

I have recently been approached by a Steering Committee of Professors from Canadian Universities to support a grant application that they are submitting to the Social Sciences and Humanities Research Council of Canada in January 2021. This grant application is entitled "Quality in Canada's Built Environment: seeking equity, social value and sustainability". With a dozen university clusters across Canada, this "SSHRC Partnership grant" application brings together representatives from cities, community groups, professional associations, industry councils, cultural institutions and universities, from coast to coast, to advance knowledge and theory around quality in the built environment. It also seeks to develop pilot projects in the pursuit of greater equity, social value and sustainability. I have spoken with the President and we agreed that it would be appropriate for the OAA to support the application. There is no financial commitment.



#### **National Initiatives**

On November 17, I participated in a meeting as a member of the Monitoring Committee for the CALA/NCARB Mutual Recognition Agreement. The following week, on November 23 I participated in a meeting as a member of the Monitoring Committee for the Tri-National Agreement between CAN/US/MEX.

I am happy to report that the revised Canadian Handbook of Practice (CHOP) is nearing completion and should be ready for publication mid-January.

Subject: Update on OAA Governance Committee activities

**Objective**: To provide Council with an update on recent activities of Committee.

The Governance Committee met on Wednesday, November 18 via Zoom. The following items were discussed:

- Operational Review was discussed. Executive Director to begin RFP process. It is anticipated that the review will begin in February.
- New Council Orientation materials were discussed and Doyle reviewed new information to be included. The revised document will be circulated to the committee for information, as well as available to all Council on ecommunities. Council orientation is mandatory for all new Councillors, including LGIC members, and individuals who may be re-elected for an additional term.

PACT has not met since the last Council meeting. The Committee will meet next on November 25, 2020.



**World Architecture Day:** The 2020 World Architecture Day celebration will be a wholly virtual experience that is set to launch on December 7 on the OAA website. Research on the 2020 Queen's Park Picks is nearing completion and will be uploaded to the website as soon as it is finalized, in anticipation of the December 7 launch.

**Bill 197 and Minister's Zoning Orders (MZOs):** PGR Staff have compiled information to help the Committee examine any implications that MZOs may have on the profession of architecture, and on the public interest. PACT will review this at the upcoming meeting and determine if any further steps are necessary.

Registrar's Review of the MMAH Guide on Secondary Suites: At their last meeting, PACT requested that OAA Registrar review the MMAH guide on secondary suites out of concern that the guide may encourage a contravention of the *Architects Act* as it does not explicitly state that an architect is required where a secondary suite is being developed above another suite. At its upcoming meeting, PACT will review and determine if any further steps are necessary.

Letter to the Minister of Municipal Affairs and Housing: On November 18, 2020, the OAA issued a letter to the Honourable Steve Clark, Minister of Municipal Affairs and Housing. The letter indicates that the OAA would like to see a copy of the Reconciliation Agreement on Construction Codes under the Canadian Free Trade Agreement that the government of Ontario signed, and that the government must involve the OAA as a key stakeholder.

**PACT Appointments:** This item is addressed elsewhere in the Council package.

#### **External Committees/Organizations:**

- CDAO: The Construction Design Alliance of Ontario (CDAO) held its annual AGM on November 6. Executive Director Doyle was elected to the board. At the subsequent forum meeting, CDAO engaged in a planning session to review the organization's mandate and vision, and to determine the organization's strategic priorities. The OAA reiterated the need for procurement to remain a focus in keeping with the original mandate of the group. The CDAO working groups (Economic Recovery; Liability) have not met since the last OAA Council meeting.
- BCACG: After a year-long hiatus, the Broader Construction Associations Consultation Group (BCACG) met on November 3. City staff have reached out to the OAA to review the City's proposed Professional Services Performance Evaluation.

Joined by Executive Director Kristi Doyle, the OAA Communications Committee met virtually on Tuesday, November 10 in anticipation of the final 2020 Council meeting in December. Much of the discussion centred on the results of a survey of participants in the OAA.chat pilot program, who were using the site for Committee collaboration (see resulting memo in package).

In addition to the information shared in this report, the Committee also reviewed the **Public Awareness Sponsorship** and **Special Project Funding programs**, setting the dates for next year as January 25 and July 26. More information will be communicated on the OAA Website and future *OAA News*.



The Committee discussed future opportunities in 2021, including a **podcast program**, revisions to current **e-communications** approaches and templates, and the creation of a holistic **content calendar** to ensure improved planning for the Association.

Representatives from OAAAS—The OAA Technology Program also briefly joined the meeting to discuss ways to streamline, harmonize, and enhance messaging, especially with regards to social media.

The meeting was bittersweet as it marks the final gathering under VP Communications Amir Azadeh who, like fellow Committee member Jeremiah Gammond, is not seeking re-election to Council.

Shortly after the meeting, OAA Communications staff welcomed Cynthia Mykytyshyn, as the new full-time Communications Specialist (replacing Marcia Cooper who retired after more than 20 years back in June).

#### **OAA** Website

Search engine enhancement continues as the number one issue identified by users is difficulty finding items on the site wide search. Comms staff have been working with Engine to make updates on the back end to improve search effectiveness.

As Comms staff and content administrators gain familiarity using the Content Management system, some functionality issues have been identified and Comms staff has been working with Enginess to resolve and make refinements.

In September, the Interns Committee reviewed the Intern and Student Associate pages and provided feedback and recommendations. A meeting with the Registrar has been set up for November 25 to review some of the Intern Committee's recommendations that are program-specific and require review and approval.

Website issues and wish list items are currently being tracked in the following <u>Google Web form</u>. The form was shared with the Communications Committee at the last meeting. Additional time will be devoted in the new year to review the wish list items in detail and determine priority items to be implemented.

#### **Design Excellence Awards**

The 2020 Awards publication has been sent out to all recipients of Design Excellence and Service Awards. It will soon be posted on the OAA Website. OAA staff continue to update the Awards Gallery on the website to include not only the 2020 recipients, but also those from previous years.

At the November Council meeting, a member shared considerations for Service Awards—specifically Lifetime Design Achievement and Order of da Vinci. In 2021, the Communications Committee will more closely examine these Service Awards, as well as the Honor Roll and G. Randy Roberts Award, continuing the work of the now-sunset Honours and Awards Committee.

#### **SHIFT Challenge**

The Communications Committee reviewed suggestions for the SHIFT 2021 Jury, which were submitted by members of Council and the Committee and included both experts from the design world and the wider concept of resiliency—the program's theme. (The goal is to also include a previous SHIFT participant.) OAA staff are now contacting the potential jurors in anticipation of announcing them in early December. Toon Dreessen, who was an integral part of the original SHIFT Task Group, is being contacted about participating as a jury facilitator. Jury Day will be held on February 16, and will be a virtual event.

Videos of four previous SHIFT participants were filmed, working with MCC. The video interviews seek to continue excitement about SHIFT and also answer some commonly asked questions. It's anticipated they will be posted on the OAA's YouTube channel in late November and early December.

**Subject:** Activities Under the Registrar October 21, 2020–November 19, 2020

**Objective:** Statistical Update

**Experience Requirements Committee (ERC):** One ERC interview was undertaken using the hybrid model during this period (Committee attends via Skype with Candidate, Registrar and Administrator, Licence attending at the OAA Headquarters). As we are now currently in lockdown the interview scheduled for December has been postponed. The Team is currently investigating a fully remote interview option with the same provider we are using in Discipline matters.

**Complaints Committee:** 9 complaints are currently before the Complaints Committee.

**Public Interest Review Committee (PIRC):** No meetings were held to date in 2020.

**Discipline Committee:** One Discipline Committee hearing was held during this period – the Respondent requested an adjournment and the Committee agreed to adjourn to January. Outstanding hearings will move forward using the virtual platform if it is agreeable to all parties. There are 16 matters to be scheduled including written hearings for 10 instances of non-compliance with the OAA's mandatory continuing education program 2016-2018 cycle.

There are currently 2 appeals in process.



**Registration Committee:** There is one appeal pending from a decision of the Registration Committee. The Court has scheduled the appeal for January 25, 2021. At this time the hearing will be proceeding via videoconference.

**Act Enforcement:** Since the last report 12 new matters were reported to the Registrar for investigation related to misuse of the term "Architect" or "Architecture" or otherwise holding out.

**Injunction:** There are no injunctions in process related to holding out and unauthorized practice.



# Licence Application Approval Distribution For Period Oct 21, 2020 - Nov 19, 2020



### Growth in Individual Status for the Period Oct 21, 2020 - Nov 19, 2020







Subject: Interns Committee Update

Objective: To update Council on the Interns Committee Initiatives

### Student Outreach Sub-Committee

- 1. The Sub-Committee with help from OAA Communications and special guest speakers from the Interns Committee, the OAA President, Executive and a Licensed Technologist OAA, held a successful one and a half (1.5) hour "Meet the OAA" virtual student outreach event on October 27 at 6:00 p.m. to architecture students at the five (5) Ontario universities. Approximately 111 people attended this event. 27 registrants completed a post-webinar survey. A \$10.00 electronic gift card for coffee or tea was sent to 24 registrants who provide their email address in the post-webinar survey.
- 2. The post-webinar survey (see attached), indicated that the students are most interested in learning about the following 4 topics:
- · paths to licensure
- finding a mentor
- logging hours as students
- getting involved at the OAA

Note that while the majority felt welcomed and had their expectations met, 40% responded that their expectations were only *somewhat* met. The Outreach Sub-Committee is currently considering how to improve future outreach events.



Also note that there is uncertainty amongst the students about the paths to licensure, finding a mentor and logging student hours. Christie Mills, OAA Registrar, has brought up the issue of the 60 credit hours with CALA and the importance of the schools to assign a specific person to work with the students and the CACB. Christie Mills, OAA Registrar is following up with the five Ontario schools of architecture to gain more insight into the process in place at the schools.

The Sub-Committee is continuing to meet weekly for 1 to 1.5 hours to work on follow up items such as posting the webinar of the OAA event, creating a FAQ page for the Student Associates section of the OAA website and creating a next steps document for the Interns Committee so they can continue to do outreach and build on the successes of our event this year.

It recommended that the Student Outreach "Meet the OAA" event be held annually.

Further development has occurred on the annual Welcome/Welcome Back email to students and the schools of architecture highlighting the benefits of becoming Student Associates and sharing relevant events and resources. A similar communication should go out annually at the end of term congratulating students and inviting them to become Student Associates (similar to what was sent to Student Associates in June 2020).

3. The Sub-Committee has been collaborating with the OAA Communications staff on these student outreach initiatives. The full-length webinar was recorded and is being edited by the OAA Communications staff for posting to the OAA website. The Sub-Committee would like to see shorter video segments of 3-7 minutes (either edited from the webinar or new educational videos) made available on the topics that were of interest to the students.

### Interns Title Sub-committee

- The Intern Architect Title Survey was "open" for 3 weeks to solicit feedback (issued to the OAA community by STRATCOM on October 21 and closed on November 11, 2020).
- Of 7590 OAA members and affiliates, 1174 individuals completed the survey which represents 15% of those contacted and encouraged to complete the survey.
- 6. A separate memo to Council is forthcoming.
- A PowerPoint presentation by STRATCOM will be given at the next Council meeting on December 4, 2020.

#### Mentorship Sub-committee

8. As of the date of this memo there weren't any new "Amazing Mentorship Stories" submitted to the OAA Communications team by the membership to commemorate mentorship month.



- 9. The feedback from the Interns Committee is that the blog of "Amazing Mentorship Stories" is valuable. One of our Committee members who is the University of Waterloo representative, has directed co-op architecture students to this blog who found it very helpful. However, evidence indicates that the current way we are soliciting for the stories from the membership is not effective.
- 10. The Sub-Committee is to work with the OAA Communications team to brainstorm different and more effective ways to obtain mentorship stories from the membership for posting on the OAA blog and social media.
- 11. As of the date of this memo, the mentorship guidebook has not yet been released to the membership.

### **Pro-Demnity Sub-Committee**

- 12. Research had been conducted on the costs and processes related to creating an audiobook of claims stories, (a budget of \$3500 was recommended for a 10-15 minute pilot podcast using written material available on Pro-Demnity's website). The breakdown of the costs of this pilot project are as follows: \$1200 for 50 minutes of studio time; \$800 for a voice actor; \$500 for a podcast producer; \$1000 for editing/packaging the claims' stories as a podcast as well as mini-teasers.
- 13. The Sub-Committee is to meet with OAA Executive Director, Kristi Doyle to better understand any operational or historical ramifications related to this initiative.
- 14. The Sub-Committee remains committed to educating Intern Architects about professional liability insurance and understanding risk mitigation when it comes to practice. It is our belief that this has benefits beyond Internship; to practices themselves and protecting the public interest.

ProDemnity provides insurance directly to the Ontario architects it insures, rather than through insurance brokers. It is not a broker.







#### **Next Steps Document:**

- A Student Engagement Review should be conducted with direct input from students to determine how easy it is for students to really participate in the OAA and what format they believe would foster the most meaningful engagement.
- 2. Increase opportunities for student participation/engagement based on the students' input. Possible initiatives might include: more student targeted communications and website functioning; increasing number of roundtables and task forces which are more issue centered and less confidential; offering shorter term and 'guest' participant status on Interns' and other committees; allow quicker, more spontaneous process to join committees; include students on more non-regulatory committees, etc.
- 3. "Meet the OAA" event should become an annual online event with emphasis on issues students have indicated in the survey that they are most interested in: Logging Hours As Students, Path To Licensure, Mentorship And Getting Involved at the OAA. Conduct survey of students to inform future outreach events.
- 4. Create video clips that address the students' primary interests. The first version of this might be to crop the 2020 "Meet the OAA" recording once an editing budget and resources become available and then embed on students' webpage. Future videos should be purposely created to address students' needs and reduce repetition on behalf of the registrar's office and OAA staff.
- 5. FAQ Addition to Student Associate webpage including questions and/or concepts raised in Q&A at event, recording link(s). Google doc has been established for subcommittee members to collaborate re content for FAQ's (NB Once our subcommittee has a draft of content which also works for comms and website management, then the content will need review by the registrar's office prior to posting.)
- 6. Improve clarity and this subcommittee's understanding of students' 60 credit hours for CACB/CALA certification. The 5 Ontario schools of architecture reach 60 CREDIT hours at different points.

The following items were noted in 2019's Next Step document for the then Intern Process subcommittee. The 2020 Student Outreach Subcommittee did not focus on these but feel that they merit future consideration given that students can now participate in the IAP.


- 7. **Revisit IAP for flexibility** for those who may need to extend process due to financial reasons or personal commitments. Now includes students who are starting to log hours.

#### **Background:**

- 1. Activities Report Vice President Practice
- 2-tier Licensing Working Group with VP Education, Office of Registrar, Education Manager and PAS: The Working Group is finalizing notes for the upcoming issuance of a report to Council.
- Practice Resource Committee Meeting on November 11, 2020.
- PACT Meeting on October 21 and November 24, 2020
- Pro-Demnity Board Retreat Meeting on October 23 & November 13, 2020
- 2. Activities Report Practice Advisory Services (key items)
- COVID-19 Updates (webpage content): Information from the first wave is still relevant during this second wave of the pandemic. Ontario has moved to a <u>colour-coded system</u> for shut downs.
- PAS received about 110 calls since Council's last meeting (between October 21 to November 19, 2020) some of which relate to COVID-19. (Note: This may include multiple calls about the same topic). This does not include email correspondence.
- Update on Requests for Proposals (RFPs) monitoring: Approximately 50 RFPs have been reviewed since January 2020, (including 12 since the November 5 Council meeting).



- 1 RFP alert has been issued since Council last met (between October 21, to November 19, 2020) with a total of 10 RFP alerts since January 2020.

Giovanni Cautillo welcomed everyone to the meeting and asked for introductions.

#### 1.0 Confirmation of Agenda

The agenda was confirmed.

#### 2.0 Review of Previous Meeting Notes (February 27, 2020)

There were no comments, however Kristi Doyle mentioned that OAA and OGCA had at the previous meeting been discussing the issues of reprisal clauses. She advised that she and Clive Thurston had not exchanged anything further in terms of OGCA's efforts to advance this matter as suggested in the meeting notes She asked Giovanni Cautillo if this is still an issue. Giovanni Cautillo advised that OGCA had addressed the Standing Committee on Finance and Economic Affairs (SCFEA) to try to get them removed from tenders. The OGCA will continue to address the issue ad hoc. The following note from the February 27 minutes was also questioned:

There was some general discussion as to which rules apply since contracts are signed pre and post the effective date of the new Act. OGCA noted that they had done a simple infographic for the transition and would share it with the rest of the group.

OGCA did not yet provide that item to OAA however will forward.

#### 3.0 Items for Review and Discussion

#### 3.1 Finalization of OAA Best Practices Document Updates (SGCs to CCDC 2)

The OAA practice advisors have reviewed the document and are waiting for final comment from legal counsel as well at the new CCDC 2 to be released. Mélisa Audet and Allan Humphries attended the CCDC 2 road show presented by CCA. It was agreed that the joint bulletin will be released by OAA and OGCA once the document is released.

#### **ACTION ITEMS:**

1. Giovanni Cautillo will check with Eric Lee of CCDC, to find out when the new CCDC 2 will be released, and to find out how long the transition period will be.

NOTE: Giovanni Cautillo has advised the following (November 19, 2020):

"I just concluded a phone conversation with Eric Lee from the CCA and have been advised that they plan on continuing to sell the previous version of the CCDC 2 (2008) until January 1, 2022. Typically the transition would be for a three (3) month period, but due to COVID-19 that has been extended to a full year. Therefore, for all of 2021 the parties will have the option of which version to utilize on a project: CCDC 2 either 2008 or 2020.

On January 1, 2022, the CCA will cease to sell the seals for the 2008 version and only the new version will be offered for purchase from that point onward. As a caveat, should any of the parties be in the possession of the previous version and seals, then they can still enter into a contract under the previous form until said seals are exhausted and then they must transition to the new version.

The CCA will be coming out with an official statement on this in the next few weeks, but I wanted to communicate to the OAA / OGCA Best Practices committee regarding today's discussion."

2. Mélisa Audet will check in with their legal counsel regarding final feedback on the supplementary general conditions and advise.

#### 3.2 Interference Drawing Best Practice Request

Lewis Cowan brought up this topic by asking what is meant to be delivered and what are the expectations. Interference drawings hold up construction. Partly it is dependent upon the project delivery model. Lewis Cowan suggested that a joint statement from OAA and OGCA is required. It was mentioned that new construction is different from renovations to existing buildings. The three items that need to be considered are the type of construction, the type of contract and the use of technology. Smaller firms tend to not use BIM. After further discussion, it was agreed that buyers of construction are not aware that if consultants are not paid enough, or are not allowed enough time to properly prepare the documents, the quality required for the constructors will not be there.

#### **ACTION ITEM:**

1. Both OGCA and OAA will prepare a report defining and explaining what is required and what interference drawings are. This will be required by January 2021. Wayne Upiter of Aecon added that he will share the key portions of Aecon's document prior to the next meeting.

# 3.4 Construction Act Update – Need for Regulatory Tune-up – industry initiative to advance further changes

Giovanni Cautillo reported that some of the aspects of the Construction Act are vague and there are gaps which need to be addressed. He advised that the original construction advisory group that looked into the new Construction Act will be re-instituted and they will spend most of the next year reviewing it. The provincial government is not interested in changing it at this time. OGCA is also working with the Ontario Bar Association. OAA wants to be involved as well. There are several groups who are working on potential changes to the Construction Act, and they should all put their ideas together. One single industry submission from construction would be more impactful then multiple separate submissions.

#### 4.0 Other Business

#### 4.1 Update from OAA

Katie Kurtin reported on the latest information for OAA including their work on climate stability, the OAA's new requirements within its awards program focusing on TEUI, adding that the OAA is also developing an new web application which will make it very simple to calculate energy usage intensity in buildings.

Kristi Doyle reported that OAA is also focussed on equity, diversity and inclusivity, dealing with COVID-19 and how practices are dealing with it, and updating OAA document 600 which is expected to be updated by the end of the year (but it was delayed due to the late release of CCDC 2). Their website has been re-done and they have a new logo. OAA has also been working on an RFP alert system which has been very resource intensive. OAA has also offered their members a no charge webinar on Unconscious Bias, which they have offered to share with OGCA.

#### 4.2 Update from OGCA

Giovanni Cautillo reported that OGCA will be holding a fireside chat with Geoff Smith of EllisDon to address their experiences with nooses found on their worksites. OGCA has also been involved with the Toronto Community Benefits Network which OGCA is now represented on. We have been approached by the Pinball Clemons Foundation to work with them on inclusion and diversity. OGCA has also met with the Canadian Infrastructure Bank regarding retrofits and green build.

Our health and safety file continues to be updated. There are procurement issues which we continue to try to resolve.

Frank Perricone brought up the issues with younger people coming into the industry who are not as experienced or thorough when developing drawings. He asked if there is a standard set of direction for architects. Settimo Vilardi advised that the OAA will review what resources they have on best practices for construction drawings production and circle back to OGCA. One document used by practices is the CHOP. It was noted that the CHOP (Canadian Handbook of Practice) is undergoing an update and anticipated release is early 2021.

#### 5.0 Next Meeting Date

Mary Wademan and Tina Carfa will reach out in January to find a date for the next meeting.

The purpose of this memo is to summarize the activities for the period from October to December, 2020

#### **Continuing Education Webinars 2021**

To generate a pool of speakers and topics that could be considered for the next round of Continuing Education webinars, the Comprehensive Education Committee issued a Call for Webinars Proposals

The Call for Webinars Proposals generated an overwhelming number of excellent responses that exceeded our expectations. The submissions included a wide array of interesting topics and perspectives, with each and every one possessing strong potential to be an OAA Webinar.



The Assessment Task Group evaluated the proposals and selected the following 11 to be offered from January to July of next year. In 2021, the Continuing Education webinars will continue to be offered on a bi-weekly basis.

June is National Indigenous History month and June 21, National Indigenous Peoples Day (NIPD), special moments to celebrate First Nations, Inuit and Métis peoples in Canada. The last two webinars on the list are scheduled to celebrate Indigenous architecture, design, and place-making in Canada and around the world. Ellen Savitsky, Manager, Education and Development is working with Matthew Hickey, who is a Mohawk from the Six Nations First Nation and a licensed architect with 12 years of experience, on finalising the content and speakers for the two webinars.

To increase the outreach and awareness of the National Indigenous History month, both webinars on the topic of Indigenous architecture will be made available to OAA members at no cost.

Planning of the July – December "semester' will resume in February 2021, after the Council Strategic Planning Session. It has been decided to continue scheduling the Continuing Education Webinars on six-month increments.

It may be noted, that the 2021 Continuing Education Webinars schedule is keeping the month of May vacant. In May, the OAA will be conducting its very first Virtual Conference. We have opened up the space for the Conference events as well as continuing education that will be offered as part of the Conference.

#### **OAA Conference 2021 – Virtual Conference**

In light of the COVID-19 pandemic and the continued uncertainty around the viability of hosting events that involve large groups of people into 2021, Council approved the recommendation to cancel the in-person 2021 Conference in Niagara Falls.

The Vice President Education and Vice President Communications and their respective committees are working with OAA staff and MCC to develop the details and programming for 2021 OAA Virtual Conference. A report in this regard from Agata Mancini, VP Education will be presented to Council in January.



#### Comprehensive Education Committee - Student Seat

The Comprehensive Education Committee was established in 2019 to oversee matters related to the entire spectrum of education, of both the public and of architectural practitioners, from primary and secondary education to higher education. Originally, the membership of the Committee was comprised of eleven (11) OAA members, including: OAA President, Senior Vice President & Treasurer, VP Education, two Interns, and one Licenced Technologist OAA.

To create more opportunities for Student Associates to get involved with the OAA, it was recommended to add a Student Associate seat to the Committee composition. At November Council meeting, Council approved the revised Terms of Reference for the Comprehensive Education Committee.

To fill the new vacancy in the Committee, the OAA currently invites applications from Student Associates to sit on this committee for a two-year term, beginning January 1, 2021. Applications will be accepted until December 4, 2020. The OAA encourages a diverse range of applicants in accordance with a formally adopted policy that strives for inclusion, diversity, and gender parity.

Once the applications are reviewed and individuals selected as candidates for the Student seat vacancy, the candidates will be interviewed by Agata Mancini, VP Education and Ellen Savitsky, Manager, Education and Development. The interviews will take place in mid-December, to ensure the name of the nominated candidate is presented to Council for approval at January Council meeting.

# Course "Fundamentals of Running an Architectural Practice" Comprehensive Content Review

The Comprehensive Education Committee approved a recommendation to initiate a comprehensive review of the course content. The course is now three years old. Due to COVID19, the profession of architecture is in a different environment forced to change usual approach to practice. It is vital to ensure the course is ready for the development of the online version.

Agata Mancini, VP Education and Yew-Thong Leong, OAA, Course Moderator and Coordinator, held a meeting to discuss the project in terms of timelines and core project phases. The next step will be redrafting the course curriculum based on the revised course timetable.

# Course "Fundamentals of Running an Architectural Practice" Development of Online Course

The development and delivery of the online version of the course "Fundamentals of Running an Architectural Practice" will be administered in partnership with the University of Toronto, School of Continuing Studies (SCS).

The OAA and SCS will work in collaboration to develop a new and engaging online course. This new course will combine OAA's vision and SCS's expertise in the design and delivery of engaging and rigorous educational experiences. The redesign of the course will:



- Extend the reach and expand access to the course through an online delivery format;
- Develop and deliver current content in a modular format;
- Increase engagement through innovative instructional strategies and online content that is visually appealing, learner-centric and delivered in an accessible, self-paced, intuitive format;
- Promote opportunities to build community among practitioners at various stages of their career;
- Ensure that the courses content and professional resources are available after the course concludes – to support ongoing goals and needs of the various audiences.

Proposed target for course launch – 2021-2022 Academic Year.

#### **Learning Management Systems**

The feasibility and benefits of implementation of a learning management system is still under a review. A report on the goals and objectives of an LMS for the OAA as well as the costs and resources required to implement and maintain an LMS be prepared before a final decision is made.

#### **Mandatory Continuing Education**

A separate memo is submitted for Council consideration on the feasibility of introducing mandatory continuing education in Cycle 2021-2022.

In reaction to COVID-19 outbreak, CACB-CCCA, measures have been put in place in compliance with Health Authorities to ensure security and safety of our staff, directors, volunteers, and applicants.

- Since March 16, 2020, operations have being performed by distance with limited attendance to the office.
- COVID-19 Alert was posted on our website and disseminated via successive Newsletters.
- Electronic voting was used several times by the Board to make decisions in reaction to the urgency of the COVID-19 situation, such us:
  - postponing the 2020 Conference to fall 2021;
  - extending Université de Montréal's Accreditation Term to October 31,
     2020 while postponing to September of the same year, the Maintenance Accreditation Visit scheduled for March 2020; and
  - Holding a Distance Board meeting via zoom on June 12, 2020, in lieu of the scheduled face-to-face meeting in Whitehorse, YT on June 12-13, 2020

# 2. INITIATIVES

## 2.1 Template for Architecture Program Report (APR)

The CACB-CCCA has reached the ultimate stage in the development of this project. The purpose of the APR template is to help reduce the overall cost of accreditation visit preparation and to achieve consistency is reporting across the Programs. The Project consists of a mandatory web-based form to be used both by the Architecture Programs and the Visiting Teams. The end result is a two-stage report that merges the previous APR and VTR documents into a single Accreditation Report (ACR).

#### 2.2 Virtual Accreditation Site Visit procedures

In reaction to COVID-19, the CACB-CCCA has initiated the work of developing procedures for Virtual Accreditation Site Visits.

#### 2.3 BEFA Remote Interview Format Development

The CACB-CCCA and the CALA Standing Committee have been working together to explore the development of a remote format for the BEFA interviews, which closely mirrors the current in-person interviews setup and rigour while maintaining the integrity of the BEFA process. The project went through several Mock Interviews and Orientation Sessions.

#### 2.4 CACB-CCCA Conference postponed to 2021

As a result of COVID-19 Pandemic, the 2020 CACB-CCCA Conference has been postponed to 2021 and new location has been selected by the Conference Committee. Location: the Marriott Hotel in Ottawa, 100 Kent Street, Ottawa, ON, K1P 5R7. New dates: September 24-25, 2021 (Travel dates: Sep.23 and 26). Invitations and call for issue papers will be sent according to the new timeline.

# 3. OPERATIONS OVERVIEWS

#### 3.1- ACCREDITATION PROGRAM

#### 3.1.1- Accredited Professional Programs

In Canada, there are 11 accredited professional degree-programs in Architecture at the following Universities: University of British Columbia; University of Calgary; Carleton University; Dalhousie University; Université Laval; University of Manitoba; McGill University; Université de Montréal; Ryerson University; University of Toronto; and University of Waterloo.

#### 3.1.2- Accreditation Visits

Visits are generally held between February and March, and the decisions are rendered at the spring CACB Board meeting following the visits. However, Due to COVID-19 Pandemic, Accreditation Visits schedule might be disrupted. The Board will ensure that the Accreditation terms and cycle are kept in alignment with the quality control requirements.

#### 2020 Cycle:

The Maintenance Accreditation Visit scheduled in 2020 has been postponed to 2021, with the option to conduct a Virtual Site Visit: M. Arch / Université de Montréal, Montréal, QC: Maintenance Visit.

In addition to the postponed Université de Montréal visit, two other visits are planned for 2021, with the possibility to adjourn them to 2022 if COVID-19 situation persists:









#### 3.2.1.2 Application received by desired jurisdiction (All graduates)












#### 3.3.1.2 Application received by desired jurisdiction

#### REPORT TO OAA COUNCIL

Following the November Council meeting, the OAAAS Board met on November 19 to consider the response to the proposals to amend the *Policy Statement on the Licensed Technologist OAA*. The Board wishes to report that it reached the following agreements.

- The Board respectfully notes that, as reported to the June 2006 Council
  meeting, OAAAS is the body responsible for considering relevant matters
  related to the Licensed Technologist OAA and making recommendations to
  OAA Council. OAAAS has thoroughly researched and reviewed, over many
  years, the matters addressed in its proposed amendments to the Policy
  Statement.
- The Board notes the President's commitment to develop a process at the
  December Council meeting to consider our proposals. If this process
  involves a committee or group, OAAAS would seek equal representation, to
  ensure that OAA members covered by the Policy Statement are fully
  engaged in the deliberations.
- 3. The Board proposes that the Council Policy Statement be returned for decision by OAA Council no later than the April 2021 meeting.

The Board also reviewed the recommendations for changes to the Policy tabled at the November Council meeting by the Registrar. We note these are restricted to matters that had been agreed some time ago, or were minor editing/updating. Understanding that substantive matters are covered by the OAAAS proposals, the Board overs a slightly revised version for consideration. Aside from including a clear statement of the rights and obligations of the Lic.Tech.OAA as a professional and member of the association, OAAAS changes are made for clarity and editing purposes only.
